

Major Campus R&R/Deferred Maintenance Projects

Over the next six years, UA will require an annual investment of between \$48 - \$58 million for facility R&R. In addition, an annual investment is required to reduce the deferred maintenance backlog to a responsible level. UA has an ongoing campus-wide maintenance program that includes the following systemic projects:


- Improvements to roads, curbs, sidewalks
- Replacement of failed roofs
- Elevator upgrades

• Electrical upgrades

• HVAC replacement

• Code and ADA corrections

At some point, minor repairs are no longer effective and an aging facility requires a more extensive renovation. The following charts are examples of the facilities and major infrastructure projects each MAU plans to renovate/renew over the next six years.



Campus Master Plan Goals



The following goals of the campus master plan are designed to achieve the vision of a well ordered and attractive campus:
