- 5.1. President's Report Josh noted it had already been a busy month. He briefly touched on the compact between the governor and university. There are still a lot of effort taking place to move planning for single accreditation along. IT Council is meeting this afternoon to discuss a single IT structure for UA. Whatever action is taken on the administration consolidation front will likely happen rather quickly. Josh's next meeting with Paul is on Aug. 28. Staff governance has not been invited to participate in the academic restructuring. Josh also reported that Mathew Mund, president of the UAF Staff Council, was elected chair of the Staff Alliance; John Moore from UAA Staff Council will serve as vice chair. Monique noted she will sit in all of the academic program meetings next week to help keep up with communicating outcomes.
- 5.2. Staff Alliance Update

Staff Alliance is working on single governance structure. They are also working on a memo requesting staff governance involvement in the development of a single UA.

5.3. Human Resources Update

CHRO McGee notified UA that she will be leaving on October 4 to return to the healthcare industry; she will help with the recruitment of her successor. SW HR also hired a new director of labor and employee engagement, Glen Gambrell. There is still the director of talent acquisition open for hire.

5.4. Legislative Update

The governor announced his vetoes on the capital budget, to include cuts of \$2.5M for UA deferred maintenance and \$2.5M for the earthquake array. The APS, AEG and WWAMI funding was restored and Dunleavy did not veto it. The governor's press office announced he will sign the operating budget next week, however, he has until Aug. 30.
