1. Call to order and Roll Call

- 4. Report of the Chair

Chair Faculty Alliance will be included in the July 23 Summit on the Strategic Directions Initiative. Regarding listening sessions, Natlinaksha Bhattacharyya commented that the UAA Faculty Senate is likely to pass a resolution noting positive aspects of SDI- recognizing its political merits, but pointing to serious methodological problems. Advance notice of this resolution has been given to Chas St. George and Paula Donson.

- 6. Complete College America (http://www.completecollege.org/)

Saichi Oba requested phone audio conference with Dan Monteith and Cathy Cahill to discuss Faculty Alliance recommendations on CCA. They recommended that UA not

formally participate, despite good intentions of the program. The UAA Faculty Senate has passed a resolution in opposition to Alaska and UA joining Complete College America. UAF and UAS Faculty Senates are working on separate resolutions also in opposition to it. There is pressure from the Governor's office to sign up. Saichi Oba did not see any possible negative consequences for signing up for Complete College America. However, Faculty Alliance members believe there are consequences.

President Gamble has requested a recommendation from the Faculty Alliance by May 15<sup>th</sup>.

Next UAF Faculty Senate meeting is May 7<sup>th</sup>
Next UAS Faculty Senate meeting is on the May 4<sup>th</sup>
Next Faculty Alliance meeting is May 18<sup>th</sup>

Dan Monteith would like this issue to run through the respective Senates before Faculty Alliance takes formal action. Dan Monteith recommended a motion be passed via email that supports the Senates' resolutions, in order to finish this by May 15<sup>th</sup>.

#### 7. E-Lab Task Force

UAA Faculty Senate has expressed resistance to the draft policy. It is being sent back to subcommittees. General conclusion is that more discussion is needed. UAA Faculty Senate will take up this issue in the fall.

UAF Faculty Senate has discussed the draft policy and generally approved it. (No vote was taken, as this is simply a consultation on a draft.) Recommendations for improved and clarified wording were conveyed to Faculty Alliance.

UAS Faculty Senate noted a conflict between the proposed effective date of the policy and their schedule for advertising course schedules. Faculty Alliance agreed to move the effective date forward from Fall 2013 to Spring 2014.

At the next SAC meeting each MAU will report on this issue, with the recommended revision to the effective date.

### 8. Health Care Changes

UAF Faculty Senate passed resolution saying they did not support the "tobacco no-hire" policy, provided reasons why. The UAS Faculty Senate passed a resolution adopting the UAF statement.

Nalinaksha Bhattacharyya requests the UAS resolution so he can mirror the language for UAA. There was a presentation at UAA on healthcare and admin were reportedly relying on employees moving to the 500 plan.
