Pat Ivey described advocacy efforts of the various governance groups and where to find information. The Coalition of Student Leaders has a student legislative conference in Juneau February 21-24 during which student leaders visit legislators. The Staff Alliance members have a spring retreat February 25 and 26 in Juneau and also visit legislators. Alumni associations partner with students for legislative visits and conduct an ice cream social in the House Speakers Chambers during the student legislative conference. The Staff Alliance also initiated an advocacy group which has been expanded to the other groups. The advocacy committee works with the UAA Faculty and Staff Association to conduct a postcard campaign to the governor in support of the UA budget. Students and alumni play a key role in their communities, at their chambers of commerce and other spheres of influence and possible support. Most legislators are either alumni, have taken classes, or members of their family have taken classes at the university. Several student leaders and student regents are working or have worked in the legislator and even been or are legislators themselves.

Vice President Julius described the new budget planning process designed to begin to involve academic program key individuals across the system in specific key areas such as health, engineering and energy to name a few.

Campus sustainability efforts were highlighted. A formal sustainability office has been established at UAA and they are looking for a director. Lots of discussion has occurred in the past few days about energy sustainability and the fuel oil crises in the rural areas.

The lack of need based financial aid for Alaska has been a Coalition of Student Leaders concern for several years. Last year, the Coalition drafted legislation which was introduced late last session and received a couple of committee hearings before the end of the session, and leveraged a \$2.5 million increment in the ACPE budget for need based financial aid. Legislators stand ready to pre-file the legislation this session.

The Staff Alliance and the Faculty Alliance have both voiced their support for the Coalition's efforts.

5.5 Student Success

The student success initiative was originated two years ago by the chair of the Staff Alliance, and quickly joined by the Faculty Alliance, the provosts, the president and the Board of Regents. It continues through a task force guided by the Vice President for Academic Affairs. The focus on the need to address key areas of concern such as access, learning communities advising and K-12 outreach have resulted in detailed budget increments for these areas in the FY10 budget.

With the proliferation of administrative councils and committees and the tendency for these groups to identify themselves as governance bodies has led to a great deal of confusion; hence the move on the part of traditional governance as defined in Regents Policy and University Regulation 03.01.01 to call for

- clarification of the definition of governance within the UA system,
- * clarification as to whether the administrative councils and committees are part of the UA governance structure and if so
 - Which administrative councils and committees are governance?
 - Who are the members of each of these groups?
 - What is the mission and role of these groups (decision making or advisory), and
 - Where is that information posted in accordance with the

Alaska Open Meetings Law?

If the administrative councils and committees are identified as traditional governance groups, there is nothing wrong with that, but shouldn't there be a Regent's Policy and University Regulation that applies to administrative governance similar to Regent's Policy and University Regulation 03.01.01?

9. System Governance Reports

9.1 Faculty Alliance

The Faculty Alliance met September 12 and discussed the draft master academic plan, the distance education legislative audit, sustainability, need-based financial aid (which the Alliance supports) and civic engagement

9.2 Staff Alliance

The Staff Alliance meets on September 23. Agenda items include salary and compensation, educational leave and release time, tuition waiver regulation changes to include non-credit courses, supervisory training, and student success

9.3 Coalition of Student Leaders

The Coalition of Student Leaders met in retreat with President Hamilton in Anchorage on October 20. Todd Marshall Closson was elected Coalition Speaker, the Coalition's equivalent of chair. Karl Wing of Anchorage was elected pro-tem. Need based financial aid, sustainability and community service top the list of Coalition issues this year.

10.1 UAA

The members of the Union of Students of UAA are working on forums with legislative candidates, community outreach and volunteerism.

10.2 UAF

Associated Students of UAF senate is working on the October student leadership conference and raising the student government fee to \$45.00.

The UAF Staff Council participated in the chancellor's convocation, non retention, compensation, the new tuition waiver for noncredit courses and the

lack of certified professional manager courses. The Staff Council also wants to start a political action committee.

The UAF Faculty Senate is reviewing the core curriculum; working with others on sustainability, child care, need based financial aid, student success and the reallocation of senate membership.

10.3 UAS

The United Students of UAS-Juneau is working on recycling, student success and sustainability.

The UAS Staff Council is focusing on recycling and the lack of daycare in Juneau

The UAS Faculty senate meets month, participates in a sustainability committee with staff and student leaders and is particularly interested in faculty research given the recent academic reorganization to a teaching-led campus and the impact of that on UAS faculty ability to do research.

The Statewide Administration Assembly is working on Thanksgiving and Christmas potlucks, canned food drive and adopting a family through Love, Inc
