5. **Strategic Direction Initiative Status** – Paula Donson

A large meeting is planned for February 20 to discuss phase 3 of SDI. Sixty-eight people: chancellors, provosts, governance groups etc. are planned to come, along with Terry McTaggart from Maine. They will look at the topics and initiatives to use at UA. All three MAUs will be involved in the selection according to priorities. Handouts of the SDI materials will be available. There are over 10 full pages of 30 or 40 products including videos, Facebook, and YouTube. Advising programs are promoted online and are in place. Paula will send to LaNora a table of all the video clips and accomplishments. They will be available directly on the SDI sites. President Gamble presented SDI before the Finance Committee and then the Academic Committee. Each chancellor will choose the teams to work on the issues.

Clarity about SDI: It is an initiative by the president as a University transformation project. The president will be handing it to the chancellor's on Feb. 20. The chancellor's will be counting on the leadership at each campus.

The metrics assist in measuring the initiatives. The process helps to monitor the health of institutions.

6. **Health Care Forum Update** – Gwenna Richardson, member of JHCC JHCC met last Friday, staff SHCC met today – RSP pharmacy and medical will be combined – notice of intent was sent to Premera. The VSP has been awarded. The motion has been confirmed to stay with the signature plan. Approximately 300 people attended the health care forums. Two of the motions have been rescinded: the spousal surcharge and the opt out option. The opt out option was the number one motion most talked about and the spousal surcharge was second. The rest of the motions are going forward. There is a decrease in the number of high-class claims. Emergency room visits rose, and it is not driven by the rural areas. Preventive visits are down. The generic brand use through pharmacy increased. Obesity is the driver to some of the chronic conditions. Eighty-four percent of the UA Diabetes Type II population is non-compliant.

7. **Legislative Outlook** - Ann Ringstad

The legislature is deep into the 90-day session that ends on April 14. The governor chose to fund salary increases, but little in the operating budget. House finance is now looking at the budget, but only the governor allotments and not the UA requests. We do not advocate for things not in the budget. It will probably be March before it is finished. There is still time to talk to your legislators. It will be mid-March before we know about the engineering buildings. 250 million dollars will be asked in a few years to cover the power plant. You can find Talking Points online on the alumni association page. The goal is to present a united UA front in Juneau to help sell the UA needs to the legislators. They are looking at less income and energy cost and oil taxes (affects the budget) which are very conservative this year.

They have completed seven of those areas and submitted the material to General Council. Board policies will go before the BOR and the UA regulations go before the president.
