5. Strategic Direction Initiative Status –Paula Donson

The February moved SDI into phase three. The work starts now. Deans and directors will be meeting with Dana Thomas three times in the next two weeks, and on May 31 they will meet with Terry McTaggart. Effect statements will be coming out from each campus soon.

6. Health Care Update

Gwenna – JHCC did not meet in March. Open enrollment started today. New plans are available. Three plans: 750, HDHP, SDHC with the HAS (Health Savings Account) available July 1, 2013. Everyone should receive a packet in the mail. Contact the your HR office with any questions. Rates dropped some but there is an increase with 3 or more children. Pharmacy will be through Blue Cross Blue Shield and include in the same health card. Cost decreased a little to employee's out-of-pocket expenses.

7. Legislative Report – Michelle Rizk

End of session report from Chris Christensen coming up soon. Session ended yesterday. University did okay. 2.5 million in general funds more than governor gave. Salary increases funded, million facilities and repair, life sciences facilities. 3.25 increase for staff. High demand program requests – 6.2 from board – governor did not include, but got one million and a half – 400 for advising, 200 for ELearning, MAPs program out of statewide and other programs. Capital budget 15 million each for engineering buildings – covers work for this fiscal year. 30 million for deferred maintenance, 2.5 million for energy and power, Juneau Campus mining workforce development, continue with cold climate project. No money given for UAF Power Plant.

9. System Governance Reports

9.1 Coalition of Student Leaders

Graduation plans occurring along with the events. Legislative Advocacy trip in February to Juneau went well. More student input will be coming regarding the differential tuition increase in the School of Management. Trying to get a feeling from students at large.

9.2 Faculty Alliance

There was a robust discussion about Massively Open Online Courses (MOOCs). Strict branding of online courses offered usually for free and no assessment of what students have learned. Faculty are not recommending accepting MOOC courses due to the dynamic venue and type of quality. Another issue is about the BOR policy focusing on academic integrity and misconduct revision: the language in the revised is overbroad and would create a burden to both faculty and students.

9.3 Staff Alliance

Spring retreat last month. Reviewing grievance policy and regulations – put forward proposals for discussion. Leave accruals, longevity. Another issue with President Gamble came up regarding bullying in the workplace. It might require a marketing campaign.

10. Local Governance Reports

10.1 UAS

Mike Stekoll – Revised faculty handbook and sent to their Senate for review and hoping to have it approved next month. Asked to make files electronic. Approved an associate science degree. Aligned transfer credits with UAA and UAF. C minus and D minus transfers. Gwenna Richardson – Closed on staff excellence award and got it in place. The winners will receive award May 15. Graduation plans are underway. In the midst of elections for new vice president and secretary.

10.2 UAA

Faculty Senate - Robert—see Faculty Alliance notes. Working on constitution to include research and also the faculty evaluation process. Training the trainers will take place for faculty. They are moving ahead on E-portfolios at an integrated level.

Denise – UAA held their elections last week for fall and they have many volunteers working on graduation.

10.3 UAF

Faculty Senate – Jennifer – approved a new BA in secondary education. The teacher training and topic training will be together. Strategic Plan will be finished this summer. They approved a centralized location for expanded course descriptions. The main purpose is to provide information for advising.

Staff Council – Juella – A lot of turnover with committee members, but added many new members in January. Just finished Staff Makes Students Count Award. Working on staff development day.

Student Council - Ayla

Student advocacy trip took place in February. Looking into differential tuition rate. Elections coming up this week for president and vice president. Hosting students
