- Also want something in the evaluation for supervisor comments.

The revised draft will be sent to HR, the performance evaluation committee and the Staff Alliance.

6.3 Staff Health Care Committee Update

Original topic of compensation task force update was postponed until October.

SHCC has existed since 2007-2008. Megan will ask Staff Council chairs to appoint two representatives to the committee of which at least one should be on the Staff Alliance and one should be from governance. Currently there are too many people on SHCC who never show up. Megan will send distribution list to the Staff Alliance so they can spot familiar names.

Win for Alaska is presenting the return on investment for biometrics, which is hypothetical data. Win is also looking at IHPs to see if there is a reduction in sick leave using employee id numbers. This is not accurate because employees also use sick leave to take care of sick children/dependents, FML and because there is a death in the family. Alliance want to know what data WIN is truly looking for and whether there is a more accurate way of getting that information. Win's use of privileged employee data to prove a business point was thought by the Alliance to be a possible HIPAA violation, whereas Primera's use of privileged employee data is to make employees healthier does not violate HIPAA. SHCC will investigate this and bring recommendations to the Staff Alliance for action.
