2. Opening Items

A. Call to Order

Chair Seekins called the meeting to order at 8:30 a.m. on Friday, February 24, 2023.

B. Adoption of Agenda

Note for the record: Regent Crum disclosed he is the CEO of Northern Industrial Training (NIT), headquartered in Palmer and offering a wide variety of vocational training and corporate support service training courses, noting some of these could be seen as competing with certain UA programs, especially with respect to particular programs within UAA's Community and Technical College (CTC), particularly the Building Technologies Division and the Transportation & Power Division, and with UAS's incipient program to provide Commercial Drivers License Training in southeast, which NIT also does.

Regent Crum said he has previously attended a meeting convened by Dean Ray Weber at UAA's CTC, to which he invited several private businesses, including NIT, to provide feedback and advice on the programs he administers. Dean Weber wants to invite Regent Crum to another such meeting, probably in March or April. Regent Crum said he's likely to accept that invitation too, but since he is a regent, he thought he should make the disclosure and make sure that he wouldn't be inadvertently violating some provision of the Executive Branch Ethics Act. Regent Crum recognized that as a regent, he cannot take or withhold any official action to affect a matter in which he might have a personal or financial interest or try to

get any employees of UA to do anything for his private benefit. Regent Crum has an interest in NIT, but participating in Dean Weber's meeting would not be trying to further that interest; Regent Crum said he would be offering advice on improving UAA's program.

Regent Crum also stated he is a member of the Board of Directors of the American Trucking Association (ATA) and works with an ATA component called Trucking University, an educational program for students of accredited universities offering scholarships for students to attend ATA's National Management Conference and Exhibition, with opportunities to attend panel discussions and industry policy committee meetings while networking with trucking executives and hiring managers. Regent Crum said he has worked with Professor Darren Prokop of UAA's College of Business and Public Policy to offer these opportunities to UAA students. Regent Crum stated he doesn't think there is a conflict of interest in continuing to do so but wanted to put the disclosure on the record.

Chair Seekins thanked Regent Crum for the disclosures and said he has consulted with General Counsel, who has confirmed that Dean Weber does indeed want to invite Regent Crum for the follow-up meeting and that he'll value Regent Crum's input as someone who is running the training programs that NIT has, and does not regard Regent Crum's advice as trying to get him to do anything other than improve UAA's programs. Chair Seekins determined that Regent Crum accepting the invitation to attend that meeting is congruent with the Executive Branch Ethics Act.

Chair Seekins stated General Counsel has confirmed with Professor Prokop that he looks forward to continuing to work with Regent Crum, and while Regent Crum's seat as a director of the ATA Board gives him a personal interest in the success of ATA's programs, there are no divided loyalties in Regent Crum continuing to work with Professor Prokop or any other UAA employees to publicize the availability of these opportunities to UA students.

POLICY CITATION

Regents' Policy 02.01.050. Collective Bargaining Agreements provides:

"The president is authorized to represent the board in collective negotiations with certified collective bargaining units; however, no agreement resulting from such negotiations will be binding on the board or the university until approved by the board."

Regents' Policy 04.11.020.B – Exclusions and Agreements, states:

"No collective bargaining agreement shall be binding upon the Board of Regents without prior approval of the entire agreement by the Board of Regents."

RATIONALE AND RECOMMENDATION

University of Alaska (UA) administration has tentatively agreed upon a successor contract with the Alaska Higher Education Crafts and Trades Employees Local 6070 (Local 6070), subject to approval by the Board of Regents.

The current collective bargaining agreement between the University of Alaska and the Alaska Higher Education Crafts and Trades Employees Local 6070 expired on June 30, 2022, which was extended by mutual agreement between UA and L6070. The extension of the CBA expires on June 30, 2023.

The university and Local 6070 reached a tentative agreement on February 2, 2023. The tentative agreement has been submitted to the Department of Administration (DOA) for approval as required by AS 23.40.212(b). Additionally, the Local 6070 union will present the tentative agreement to their bargaining union members for ratification. Subject to ratification by the bargaining unit members, and approval by the DOA and the Board of Regents, the successor CBA will be effective for the period July 1, 2023, through June 30, 2026. Pursuant to AS 23.40.215, the monetary terms of this collective bargaining agreement are subject to annual appropriation by the Alaska Legislature.

RATIONALE/RECOMMENDATION

The president and selected members of the university administration are routinely designated by the Board of Regents to handle any duties and responsibilities relating to classified information in connection with contracts with the Department of Defense and other federal agencies. These individuals are given an extensive security screening and are the only members of the university administration to have access to classified information.

The university has received similar security clearances since the mid-1950s. Execution of the resolution means that regents and other members of the administration will not have access to the classified information and are not in a position to affect the handling of classified information, thus do not need to be processed through security clearance procedures. WHEREAS Congress passed, and the President of the United States signed into law, the Naval Petroleum Reserves Production Act of 1976, which authorized oil and gas leasing, exploration and operations in the National Petroleum Reserve in Alaska (NPR-A).

WHEREAS the Willow Master Development Plan Final Supplemental Environmental Impact Statement (SEIS) indicates the project could result in the production of 180,000 barrels of oil per day and up to 629 million barrels of oil over the life of the project.

WHEREAS the Willow Project would ultimately increase employment opportunities and generate government revenues that support important public services including higher education in the State of Alaska.

WHEREAS the Willow Project could create thousands of jobs during construction and hundreds of long-term drilling and operations jobs over the life of the project. In addition, current estimates suggest that the Willow Project could generate between \$8.7 billion to \$17.1 billion in revenues with Alaska receiving between \$4.8 billion and \$10 billion. The new jobs and revenue could result in positive economic impact for the state, local and regional economies in Alaska.

WHEREAS the Final SEIS does not identify significant environmental issues with the Project beyond what is already happening on a global scale, particularly as it relates to climate change.

WHEREAS the Willow Project has received support from a wide variety of stakeholders such as the cities of Utqiagvik, Wainwright, Atqasuk, the Alaska Federation of Natives, Arctic Slope Regional Corporation, Kuukpik Village Corporation, North Slope Borough, Alaska Native Village Corporation Association, and the ANCSA Regional Association and will result in billions of dollars in revenue to the communities of the North Slope.

THEREFORE BE IT RESOLVED that the Board of Regents of the University of Alaska supports the Willow Project and urges the U.S. Department of the Interior to approve the BLM's preferred alternative (Alternative E). (video timestamp 3:13:40)

Honorary degrees may be conferred upon approval of the Board of Regents.

Rachel Decious, University of Alaska Anchorage (UAA) gymnastic team member, stated the gymnastics team supports UA's strategic initiatives and thanked President Pitney and Chancellor Parnell for their support of the team.

Pat Druckenmiller, UA Museum of the North director, shared the 2022 visitor's attendance numbers, noting 80,000 compared to 90,000 pre-pandemic, reviewed projects and activities taking place at the museum and stated the first open house since the pandemic is on March 25, 2023.

Montana Fairbairn, UAA gymnastic team member, shared the team's academic goals and student successes, noting nine athletes had 4.0 GPAs during the fall semester and reviewed the team's victories and high scores.

Emily Walker, UAA gymnastics team member, encouraged the board to participate in UA Giving Day beginning February 21, 2023.

Hannah Mevencamp, University of Alaska Fairbanks (UAF) student, shared her experience with the UAF earth science group, noting her student research efforts and her work to solve the complex issues of the future.

Katie Lester, UAA student studying social work, shared her concerns regarding accessibility and inclusion challenges at UAA, noting the designation of restrooms in some buildings.

Shelley Ebenal, Foundation Health Partners CEO, stated support for the UAF LPN program and noted the importance the program would provide for her organization.

Monique Musick, System Office Public Affairs Communications & Marketing manager, welcomed the new board member and shared information regarding UA communications from the Public Affairs Office, e.g., UA Daily News, UA Capitol Report, and the Did You Know weekly publication.

Andrew Roe, UAF alumni and owner of Latitude 65 Brewing Company, said \$1 from each Nanook Golden Ale purchase goes to the Nanook scholarship program, noting to date, in a five-month time frame, the partnership has provided \$8000, and stated criticism should not be about the alcohol or the partnership, instead, it should be about the tragic abuse of alcohol in Alaska.

Jill Dumesnil, University of Southeast (UAS) Juneau math professor, stated she is a United Academics faculty member, spoke in support of small programs, noting smaller programs are necessary and provide unique educational experiences, and said support needs to continue for all small programs.

Mary Beth Loewen, UAF Alumni Association president, shared recent alumni activities within and outside of Fairbanks; mentioned UA Giving Day; reviewed the association's giving history and said the elections for new alumni directors is upcoming.

Karen Lapp, Fairbanks resident, stated support for the UAF LPN program and noted the importance of building educational partnerships.

Michael Ciri, Juneau resident, welcomed the new board members; shared his passion for the GED Achiever Scholarship he and his wife established at the UA Foundation; encouraged participation in UA Giving Day and stated he and his wife would match, up to \$10K, all funds donated to the scholarship during giving day.

Sarah Martin, Fairbanks resident, stated support for the UAF LPN program.

Elizabeth Ripley, MatSu Health Foundation president and CEO, shared the foundation's support for the conservation easement surrounding the MatSu Farm area; encouraged the board to keep the easement, is thankful for UAF's engagement in the

community easement meetings and looks forward to the continued partnership.

Heather Swanson, Anchorage resident and UA Accessibility Work Group member, welcomed the new board members; is thankful for captioning provided during the Board of Regents' meetings; stated disability is a critical issue to support; mentioned the Department of Education Office of Civil Rights Voluntary Resolution of Agreement regarding accessibility and said the work group is working with President Pitney and the chancellors to make accessibility training mandatory for all UA staff.

Nicole Welch, Foundation Health Partners chief human resources officer, stated support for the UAF LPN program.

Connor Swanson, UAA and UAS student, stated he is hard of hearing and is thankful for the captions during the Board of Regents' meetings; requested the board take a proactive approach to accessibility, noting the lack of accessibility is disheartening and reminded the board accessibility is mandated by the federal government.

Karen Jensen; UAF librarian, said in her 25 years at UAF, she has witnessed the personal growth of students; stated there is a deeper and broader mission for the university than workforce development; said attending a university is the time for students to explore ideas, themselves, critical thinking, new views, other ethnicities and to appreciate the complexity of things and encouraged the board to remember intangibles like these when considering budgets.

Nate Kile, Alaska Center for the Blind and Visually Impaired program director, stated the greatest barrier is accessibility and said rather than just providing accommodations, it is important to meet the proper accessibility standards and abide by the standards.
