# 2. Opening Items

## A. Call to Order

Chair Seekins called the meeting to order at 8:00 a.m. on Friday, May 26, 2023.

# B. Adoption of Agenda

Note for the record: Regent Perdue reiterated and supplemented some disclosures she made during the May 25, 2023, Facilities and Land Management Committee meeting, stating she is not a member of that committee, did not participate in any committee votes, and on the following items and she refrained from participation in the discussions and deliberations.

She stated with respect to the formal project approval for the University of Alaska (UAA) Alaska Leaders Archives/Consortium Library Renovation; she is a board member of the Ted Stevens Foundation, which is an integral partner with UAA on this project, with a memorandum of agreement currently under negotiation. Regent Perdue said she should not vote, deliberate, or participate in the discussion on that matter, and asked Chair Seekins to make a determination on the record, noting the same item is one of the specifically listed components in the proposed FY24 Capital Budget Distribution Plan, item 7.D. on the agenda.

She also stated with respect to the project change request for the University of Alaska Fairbanks' Bartlett and Moore Hall Modernization & Renewal, and the informational item before the Facilities and Land Management Committee on the Troth Yeddha' Indigenous Studies Center, the firm of Bettisworth North is involved in both of those items and, although her spouse long ago sold his ownership interest in the firm, he is still a part-time employee of the firm. Regent Perdue said neither of these is an action item before the full board, noting the project change request was approved by the committee, without her

participation in the discussion or the vote, and the committee's approval does not require board ratification. She also stated the Troth Yeddha' Indigenous Studies Center was an informational item, not requiring board action.

Chair Seekins stated after consultation with UA General Counsel's Office, he determined for the reasons Regent Perdue explained, he agreed that she should refrain from any vote, deliberation, or participation regarding the formal project approval for the UAA Alaska Leaders Archives/Consortium Library Renovation, as she did during the May 25, 2023, committee meeting. Chair Seekins said that particular item will be removed from the consent agenda, so Regent Perdue will need not refrain from participation in the remaining items on the consent agenda, and the board will take a separate vote on the formal project approval from which Regent Perdue will refrain from any participation. Chair Seekins determined for Motion #2 under item 7.D. on the agenda, approval of the FY24 Capital Budget Distribution Plan, which does specifically include the distribution to the UAA Alaska Leaders Archives/Consortium Library Renovation, Regent Perdue will refrain from voting, deliberating, or participating, noting that only applies as to Motion #2. Regarding Motion #1 under item 7.D., he determined Regent Perdue could participate and vote, noting Motion #1 simply accepts the capital appropriation in the aggregate and does not specify any particular projects. Chair Seekins found there is no significant personal or financial interest on Regent Perdue's part that should preclude her from participating in Motion #1, noting the board will take two separate votes on item 7.D. and determined Regent Perdue could participate in Motion #1, but should not in Motion #2.

Chair Seekins said regarding the Facilities and Land Management Committee's approval of the project change to the Bartlett and Moore Hall Modernization & Renewal, and as to the informational item on the Troth Yeddha' Indigenous Studies Center, the board doesn't anticipate there will be any votes by the full board, but there may be further discussions. Chair Seekins agreed that Regent Perdue should refrain from the discussions for the reasons she explained, as she did during the May 25, 2023, committee meeting.

Regent Crum stated his business would be signing an agreement with the eLearning component of the University of Alaska Fairbanks (UAF), offering his employees a 10 percent discount on courses taken for professional development. He said the agreement is identical to agreements that UAF eLearning has with several other Alaskan businesses and is willing to offer to others, so his business is not receiving any unwarranted special treatment, noting the agreement will not come before the board, so there is no occasion on which he would be taking any action on it in his role as regent. Regent Crum stated he understands that whenever there is a contract between the university and regents individually or businesses owned by regents, a disclosure should be made even though there is no actual or potential conflict.

Chair Seekins said after consultation with UA General Counsel's Office, he determined there is no conflict presented by Regent Crum's business entering into the agreement, and since there is no agenda item relating to that, he didn't have any reason to have Regent Crum refrain from participating on any particular item at during the May 26, 2023 meeting.

#### RATIONALE AND RECOMMENDATION

President Pitney and Vice President Rizk presented a summary of the supplemental FY23 capital budget appropriation and discussed the capital funding distribution.

The FY23 supplemental capital budget includes a \$60.0 million net decrease to UA's federal receipt authority.

UA Fairbanks Seward Marine Center Research Vessel Infrastructure (-\$64 million) - the grant award was not received for the SMC R/V Infrastructure. This change leaves \$30.4 million in federal receipt authority related to this project in the event another grant opportunity becomes available.

UA Anchorage Health Workforce Expansion and Diversity Funding (\$4 million) - this project proposes to begin renovating the Sally Monserud Hall to expand UAA's College of Health (CoH) health workforce clinical training facilities including, increased laboratory space and remote learning technologies. The Economic Development Administration (EDA) informed UAA that they will be receiving the Health Workforce Expansion and Diversity Funding. The total award is \$5.0 million, of which \$4.0 million is federal funding and \$1.0 million is match funding from UAA. This project received Formal Project Approval May 26, 2022.

Natural Resources Fund is to be used to "provide a margin of support over and above" what otherwise would be possible through traditional state, federal and private sources, and used to provide funding to projects and programs necessary to establish or enhance the quality of the university's academic programs, research, or public service. The sources of the funds available comes from the spending allowance generated by the Land Grant Endowments, currently set by the board at 4.5% of the average of the December 31 market value for the immediately preceding five years of the fund. Withdrawal of earnings in any fiscal year is limited to the unexpended accumulated earnings of the endowment as of the preceding December 31.

#### LONG-TERM COMMITMENTS

<u>UA Scholars Program</u>: The allocation request is based on the program being the university's largest scholarship outreach program and consists of an award of \$12,000 paid over a period of eight semesters at \$1,500 per semester. The award is available to the top ten percent of the graduates from every high school in Alaska. The increase in the total allocation to the Scholars Program over the prior year reflects a renewed interest in the program by graduating seniors. As of May 4, 2023, 622 of the 948 (66%) designated UA Scholars had applied for admission within the UA System. This represents the most applicants through the month of May since 2019.

<u>Land Management:</u> The allocation is based on board policy that provides a portion of the spending allowance for the management and maintenance of university land. The allocation will help fund support costs for the federal land grant initiative and additional outreach to develop lands.

<u>System-based Scholarships:</u> The allocation request represents awards offered as community goodwill, through seven organizations as well as the state's foster youth program. Consistent with the UA Scholars program the community awards have been increased by \$125 per semester as of June 2014. The foster youth award amount covers 144 credits of tuition for 10 semesters over six years. The foster youth cost is variable with tuition increases.

Institute of Agriculture, Natural Resources and Extension (IANRE) USDA Grant Match and Cooperative Extension Support:

Cooperative Extension has used these funds to build capacity in Alaska communities by providing significant portions of salaries of employees providing educational outreach related to 4-H and natural resources. The funding has financed the majority of work done by the extension's Bethel agent, Sitka program assistant, Fairbanks state 4-H program faculty, Mat-Su 4-H faculty member, Kodiak and Bristol Bay 4-H program assistants, and the Southcentral natural resources programs headquartered out of the Palmer Research and Extension Center. In addition, the Kenai Peninsula agriculture agent and natural resource assistant and Anchorage Extension coordinator were covered by the NRF as well. With this funding, the extension has been able to deliver youth-driven programming including healthy living, cultural appreciation and suicide prevention. The programs housed within IANRE are directly connected to the land-grant mission and have a federal 1:1 match requirement for capacity building grants and agricultural research (e.g., Hatch Act, Smith-Lever Act, McIntire-Stennis capacity grants). An increase of \$100,000 (25%) is being proposed for FY 2024 to assist UAF in meeting match requirements.

<u>University of Alaska Press</u>: The allocation request is based on a long-standing commitment to supplement their operations, most recently affirmed by the board in June 2020. The UA Press entered into a consortium agreement in FY22. The Natural Resources Fund allocation will be used for mandatory membership dues in the consortium.

#### SUPPORTING GOALS AND MEASURES

<u>G&M Emerging Opportunities</u>: A series of internal grants will be awarded for initiatives and investments designed to produce results in achieving the goals:

Contribute to Alaska's economic development, skilled workforce and engaged citizenship

Special attention will be given to the priority focus areas and identified by the board.

<u>University of Alaska Anchorage</u>: The University of Alaska Anchorage aspires to reach the goals approved by the Board in February 2022. Specifically, UAA will use NRF funds to 'contribute to Alaska's economic development, skilled workforce and engaged citizenship' by removing barriers to educational attainment. Through a simplified admissions process, tailored financial aid support, and community campus outreach, UAA stands ready to grow Alaska's workforce by preparing graduates to transition into jobs.

University of Alaska Fairbanks: The allocation request is intended to 'grow our world-class research' with targeted initiatives,

the

such as support for postdoctoral scholars and PhD students. This effort will help advance UAF's goal of achieving tier 1 research status. Attaining tier 1 research status can provide global recognition for high research productivity; enhance competitiveness for funding resources; attract globally competitive faculty, staff, and students to improve the quality and caliber of UAF research and education; increase student enrollment; and provide local and regional economic benefits to the broader Fairbanks community and rural campuses and communities throughout the State.

<u>University of Alaska Southeast:</u> The University of Alaska Southeast aims to further student recruitment for its Maritime, Mariculture, and Ocean Economy programs at its three pristine and ideally located campuses. UAS remains committed to the Fisheries and Mariculture industry and is excited to further serve this industry in providing a skilled and trained workforce and promoting research, education, and collaboration across the industry and Alaska as a whole.

<u>University of Alaska System</u>: The System Office is proposing start-up funds for an expanded revenue development arm. The objectives include continued work on current development projects; working with the universities on development priorities in the short term (1-3 years) and mid-term (3-5 years) including public private partnerships and developments beyond land, sale, and lease; securing consultants that will analyze university land portfolios for development opportunities across Alaska; and continued progress at streamlining the UALM processes.

<u>Construction Management:</u> Skilled construction workers are critical to building and maintaining Alaska's roads, ports, bridges, and other infrastructure. It is a University of Alaska priority to address Alaska's construction workforce needs by training a local workforce and providing highly skilled graduates to industry partners. This initial investment will provide support for construction programs at the University of Alaska Anchorage, the University of Alaska Fairbanks, and the University of Alaska Southeast to expand career awareness, market existing programs, increase online delivery, and deliver hands-on training to rural communities.

#### **GOVERNANCE SUPPORT**

<u>Staff Development Fund</u>: Promote staff and supervisor training and development, recognition, and mentoring/coaching opportunities. A 20% increase is being proposed for FY 2024.

<u>Faculty Initiative Fund</u>: Funds will be used to provide opportunities for inter-university collaboration to promote teaching and scholarly activities that enrich the student experiences leading to equity in student success. A 20% increase is being proposed for FY 2024.

#### OTHER

<u>University of Alaska Press (one-time)</u>: Funds will be used to cover one-time costs related to inventory and accounts receivables expenses the UA Press will no longer be able to recover.

<u>Leadership and Team Development (Innovation Fund)</u>: Funds will be used to foster a culture of innovation through investments in leadership development, administrative efficiency and process improvement, and internal and external partnerships. (video timestamp 3:54:47)

# 20. Public Testimony, from May 23, 2023

Jill Dumesnil, University of Southeast (UAS) Juneau math professor and a United Academics Union representative, said the regular nine-month contract period for UA faculty has ended, although many faculty members are still working, conducting research, teaching summer classes, or working second or third jobs to support their families and stated very few UA faculty have the luxury of summer vacation.

Paola Ruano, University of Alaska Anchorage (UAA) gymnastic team member calling from Medelin, Columbia, provided an update on the team's community engagement efforts and its volunteer work.

Claudia Lessig, incoming UAA gymnastic team member calling from Springfield, Texas, shared why she chose UAA and its gymnastic program.

Anna Wensel shared her experience with the Alaska Advantage program, stated she earned 30 hours of college credits while attending high school and thanked the board for supporting the program.

Harrison Israels, UAA ice hockey team member calling from Toronto, Canada, shared the team's successes and thanked the board for supporting the program.

Kimberly Bergey, Raven Homeschool program director calling from Palmer, Alaska, shared student successes with the Alaska Advantage program, noting during the fall of 2022, Raven students took 85 classes, and in the spring of 2023 a total of 200 credits; said the advantage program is a great option for middle school students remotely located and for students to have access to college credit courses.

James Muller, Anchorage, Alaska, thanked the board for its service; stated concern regarding the calculation of retroactive pay raises for faculty; reviewed his 40-year teaching career and said it is inequitable not to pay faculty for the entire year they worked.

Jeff Jessee, past Alaska Mental Health Trust CEO and past UAA College of Health dean calling from Anchorage, Alaska, stated opposition to the University of Alaska Fairbanks (UAF) partnership with Latitude 65 Brewing Company, noting public funds are being used to advertise alcohol beverages to underage people; said UAF has violated its alcohol policy and encouraged UAF to focus on accountability.

Shelley Ebenal, Foundation Health Partners CEO calling from Fairbanks, Alaska, stated support for the UAF health care management and leadership program.

Nate Bauer, UA Press director calling from Fairbanks, Alaska, shared UA Press information regarding licensing agreements, marketing efforts, and its robust internship programs for students and thanked the board for its support.

Karen Taylor, Foundation Health Partners education department employee calling from Fairbanks, Alaska, stated support for the UAF health care management and leadership program.

Togi Letuligasenoa, Fairbanks, Alaska, stated a renewed interest in the UAF campus ice rink, noting the venue is a centerpiece of activity and would contribute to the student lifestyle experience and thanked the board for its support of athletics at UAF.

Douglas Herrin, Foundation Health Partners physician calling from Fairbanks, stated support for the UAF health care management and leadership program.

Karen Melin, Fairbanks North Star Borough School District chief administrator calling from Fairbanks, Alaska, provided information regarding the school district's involvement in the partnership with the UAF North Star College, noting student successes and the recent expansion to include 180 high school juniors and seniors.

Erik Largen, UAF men's hockey coach, stated on behalf of the athletic teams and the entire department an extension of thanks for the board's support of athletics.

Soumitra Sakhalkar, UAF student, shared his experience with his professors and their help obtaining his geophysics certificate and thanked the department heads for his success.

Brandon Briggs, UAA Department of Biological Sciences associate professor, thanked the board for offering public testimony; stated his concern for the retroactive pay calculation, quoting an article from the faculty's collective bargaining agreement (CBA) regarding across-the-board pay increases and asked the board to please adhere to the CBA.

Tiffany Hall, Recover Alaska executive director calling from Anchorage, Alaska, spoke in opposition to the UAF partnership with Latitude 65 Brewing Company, noting its marketing is directed to underage drinking; stated it is irresponsible for a university to engage in such marketing; said prior statistics and data regarding underage drinking have been shared with the board and mentioned the change in the alcohol policy at UAF after two events promoting the partnership.

Lance Howe, Anchorage, Alaska, expressed support for the retroactive pay for faculty who retire before June 4, 2023; said there has been an inability to keep faculty salary in line with inflation, noting many are leaving Alaska and stated there is an imbalance between university administrators pay and faculty and staff wages which is creating low morale.
