AMENDMENT PASSED: The Board of Regents amends the proposed motion setting Academic Year 2027 Tuition Rates by augmenting the proposed tuition increase of 3% to add an additional 1% increase, resulting in a total 4% across the system tuition increase, with the expectation that revenue generated by this augmentation will enable the universities to increase their support and funding for two student-related Board initiatives: the enhancement, improvement and extended implementation of student mental health support programs and counseling services; and additional strategic financial investments that directly support and accelerate the achievement of the university's Systemwide Attainment Framework goals. This motion is effective November 7, 2025.
