- 5.1. Regulation Review R09.11.010 Immunization and Tests for Communicable Diseases Draft for Review Rationale Health and Student Services enforces, Residence Life takes a passive stance since vaccine records are covered by HIPPA. Mathew noted he thought the requirements were only for students living in student housing (density), rather than age. Up to this point, this immunization has been optional for students in the dorms. Kiwana noted there was something similar at her school in the Lower 48 and that also had an age limit; she was able to opt out due to age (but she also lived off campus). Mathew will seek feedback from his health contacts to see if there a reason for the age requirements.

- 7.1. UAA Staff Council Budget has dominated meetings; had Chancellor Sandeen at the last meeting and discussed budget and that we are sitting tight and waiting to see how it plays out; discussed developing an advocacy memo; started process on a mentorship program; working with HR on leadership development;
- 7.2. UAF Staff Council continued in-meeting education series (debate and what that means); UAF housing now has a first year live-in requirement; Blue & Gold Day was approved by Fairbanks city and borough mayors; Safe Zone training on campus an outreach to the LGBQT+ community; staff morale forum well attended and interesting conversations was a good forum for communication regardless of individual morale; HR is planning to activate the 360-module in MyUA to allow for feedback on supervisors; held a rally in support of UAF; they are also in the middle of their institutional accreditation review and have heard there is still confusion between the loss of accreditation at the UAA SOE; InsideOut event was held and brought parents to campus with their students; will sponsor a blood bank event later in March; a bone builders food drive; e-sports conference to promote academic tournaments and combining those types of activities; staff recognition day will now include development (which is how it has happened in previous years but it had been proposed that it not be included this year);
