6.2 Honorarium for Shauna and Jarmyn

Jarmyn suggested a resolution be drafted for Amber Averette in Juneau for all her work during the Legislative Sessions. Shauna said she would prefer a resolution. Ayla said Shauna and Jarmyn deserve something else as well. Ayla would be in support of a "resolution of appreciation" for Shauna, Jarmyn, and Amber to put in a personnel file. 7. Discussion Items

7.1 Student Fees

Shauna opened the discussion because there are many students attending campus by distance and do not reap the benefits of student fees. Jarmyn stated all the fees students are charged. Juneau is going away from it and paying a flat fee per credit. Line items made things more complex. The distance students still pay the fee but if on campus they would have access to the same benefits other students receive. Shauna said this topic still needed attention and discussion regarding the students who do not have a campus close by.

Put on the agenda for the August Summit to do research and to update the new people coming in to the Coalition. Ask Saichi Oba to come in and give his perspective with a work session for an hour or two. All the Coalition students will do research and come together at the Summit to discuss.

7.2 Differential Tuition

Shauna will post on Facebook to get student input. This topic needs students to comment. Jarmyn explained about the UAF SOM's proposal regarding the differential tuition. BOR said teaching is a high demand program in Alaska but tuition going up would cause others to not go to school to become a teacher. Shauna stated the concern is about putting this before the BOR before going through the Coalition and the president. Jarmyn said it seemed wrong to have the BOR vote on this in the summer when the students are away. Discussion revealed, overall, the students were not informed across the university and it raised concern that any high demand college could raise tuition.
