Not brought up to president's cabine
- Tweakingwhathas been put together so far.

Summary Jon from Susan: pres cabinet keep the old charge or wait until the new president comes. On February 10 there will be a joint presidents cabinet/SAC meeting. Apparently we are going to spend the entire day on the AMP. Remember the thing we have been talking about has been process. Very much appreciated the process outlined in the original charge and we want to stick to it. There is no academic in the master plan. It is an administrative master plan. It is not about whether or not anchorage has a phd; it is about the money to support that phd. The actual authority rests with pres office and the Board of Regents. Thye are trying to pass off that authority. If I take this to the senate, I would be torn a new one.

Option 1: shoot it. Each mauhas its own master plan
