Call to Order and Roll Call

Adopt Agenda and Approve Minutes

Chas St. George updated alliance on Shaping Alaska's Future. Chancellors have submitted their edits and the edits will be entered into a new draft and then submitted through governance and to leaders throughout the system. Alliance was asked to provide comments and suggestions to LaNora and she will forward them to VP Thomas. President Gamble will be meeting with Alaska

Native Studies next week. The administration want to incorporate governance more in the process.

Staff Alliance Chair's Report

Carey stated he received and accepted resolutions from Anchorage APT and Classified Council on the Tuition Waiver Benefit. In response, he wrote a resolution for the Smoke Free/Tobacco Free for Alliance.

Staff Governance Reports

UAS Staff Council – Gwenna

The council had a retreat last month. They talked about the May Staff Development Day. They are trying to get a webinar on Healthy Roads to discuss wellness issues. They discussed the Tuition Waiver Benefit proposed cut by Regent Fisher and the consensus is to not see the cut. They support keeping it. Gwenna will send a resolution to LaNora.

The staff discussed the winter closure and the requirement to take annual leave or LWOP and the hardship it creates for some employees. UAS has questioned the chancellor about an admin leave day like the president gave Statewide.

UAA

Classified Council – Met on Dec. 5 and talked about the UAA Assembly conducting the bullying awareness seminar. Talked about... Working on unified APT Classified brochure...program prioritization...voted for the resolution on the Tuition Waiver Benefit

After they finish reviewing, they will share with Staff Alliance. They will talk to HR Eric Seastedt on the new Performance Evaluation.

When they met with the vendors, they all shared information. They talked about people who have illnesses and protect them from bombardment. JHCC did not have input on the actual contracts but they have input on wording and feedback for guidelines and what employees are looking for in their insurance provider.

Staff Alliance discussed the need for more clarity regarding JHCC and the purpose behind it.

Carey asked the staff if there were any issues for him to include in his presentation before the board. He shared there was talk about an unfriendly atmosphere toward staff. Tamah and Brad agreed there are issues creating this atmosphere due to no compensation increases and the tuition waiver benefit cut being proposed. It appeared staff were the target for cuts.

Staff were asked to review the resolution Carey drafted. Brad moved to bring the resolution to the floor and Ashley seconded. Discussion took place and edits were made to the resolution. Gwenna motioned to accept the amended resolution and Brad seconded. The vote was unanimous

Tuition Waiver Benefit Concern

MOTION: Gwenna motioned to create a motion in support of the resolutions on the tuition waiver benefit cut and Tamah seconded. LaNora said she would draft the memo/motion and send it out to the group for review. The local staff councils' resolutions would be attached to it.
