Preliminary Admissions and Course Registration Fall 2025 Semester July 14, 2025

The following is a comparison of student activity 6 weeks prior to the first day of instruction for Fall 2025 and Fall 2024 semesters. Information reported here is normalized relative to the first day of instruction for a given term, to provide accurate trend comparisons and projections at the university and system level. Fall 2025 semester instruction begins Monday, August 25 and Fall 2024 semester instruction began Monday, August 26. Trends are preliminary at this point.

Applications

Over 14,340 applications have been started by prospective students for Fall 2025, up 22 percent (2,606) from Fall 2024. UA Anchorage was up 5 percent (285), and UA Fairbanks increased 47 percent (2,438), while UA Southeast activity decreased 14 percent (99) year-over-year. About 62 percent of applications for Fall 2025 have resulted in admission to a program or course. Of the 8,948 students accepted so far, 31 percent (2,736) have elected to enroll, to-date. This represents an increase of 104 students, year-over-year, in the number of newly admitted students who enrolled.

Course Registration

With less than two months to go before the first day of classes, 12,400 students have registered for 125,858 Fall 2025 semester student credit hours (SCH). Year-over-year this represents a nearly 5 percent growth percent in headcount (534 additional students) and an over 6 percent increase in SCH registration (7,423 SCH).

Compared to last year at this time, UAA headcount is up over 5 percent (342 additional students), and SCH is nearly 8 percent higher (4,846 SCH). See page 2 for additional UAA detail by academic unit.

UAF headcount increased 5 percent (234 students), with students registering in about 7 percent more (2,992) SCH year-over-year. See page 3 for additional UAF detail by academic unit.

At UAS, student headcount is nearly 4 percent (40 students) lower and student credit hour registration dropped about 5 percent (415 SCH) compared to this time last year. See page 4 for additional UAS detail by academic unit.


