Preliminary Course Enrollment and Revenue Activity Fourth Week of Fall Instruction September 25, 2023

The information below compares preliminary fall 2023 and 2022 semester activity four weeks after the first day of instruction and provides a working estimate of final fall 2023 closing enrollment levels.

Nine out of ten students who will eventually enroll by December have registered so far, accounting for an estimated 97 percent of closing fall 2023 student credit hours (SCH). Students enrolling in short and late start classes will generate additional headcount and credit hours through the end of the term. Almost 2,000 additional students are anticipated to enroll by the close of fall 2023 for a total of nearly 20,900, an increase of approximately 3 percent (~660 students) from fall 2022 closing. Student credit hour registration is also expected to increase roughly 4,700 SCH by the end of the term, reaching slightly above 170,000 SCH and representing an increase over 3 percent (nearly 5,700 SCH) from fall 2022. Refer to pages 6 and 7 for graphs displaying historical and current course registration patterns for headcount and SCH, respectively.

As of September 25, 2023, 18,896 students had registered for 165,506 fall semester credit hours, system wide. This represents a 2 percent (306 students) increase in headcount and a 3 percent (5,202 SCH) increase in student credit hour registration over this time last year.

As of week 4, UAA student headcount was 3.6 percent (385 students) higher and student credit hour registration 3.5 percent (3,165 SCH) higher than last year at this time. UAF headcount was 1.3 percent (86 students) higher and student credit hours 4.5 percent (2,514 SCH) more compared to fall 2022, to-date. UAS headcount decreased 2.0 percent (39 students) and student credit hour registration fell 3.4 percent (476 SCH) year-over-year. Currently, total net tuition and fee revenue is up nearly 5 percent (\$2.7M) system wide compared to fall 2022. Undergraduate tuition revenue increased about 5 percent (\$1.8M) and graduate tuition revenue increased almost 11 percent (\$0.5M) compared to last year. UAA revenue is up 3 percent (\$1.0M) and UAF revenue is up nearly 8 percent (\$1.7M). UAS revenue has reach nearly the same level observed at this time last year. Data for fall 2022 applications, admissions, and program majors with report dates of September 23 - October 2, 2022, is not available. 
