Preliminary Admissions and Course Registration Fall 2025 Semester July 21, 2025

The following is a comparison of student activity 5 weeks prior to the first day of instruction for Fall 2025 and Fall 2024 semesters. Information reported here is normalized relative to the first day of instruction for a given term, to provide accurate trend comparisons and projections at the university and system level. Fall 2025 semester instruction begins Monday, August 25 and Fall 2024 semester instruction began Monday, August 26. Trends are preliminary at this point.

Applications

Over 14,560 applications have been started by prospective students for Fall 2025, up 21 percent (2,574) from Fall 2024. UA Anchorage was up 5 percent (292), and UA Fairbanks increased 46 percent (2,401), while UA Southeast activity decreased 13 percent (100) year-over-year. About 63 percent of applications for Fall 2025 have resulted in admission to a program or course. Of the 9,174 students accepted so far, 33 percent (2,736) have elected to enroll, to-date. This represents an increase of 120 students, year-over-year, in the number of newly admitted students who enrolled.

Course Registration

With a little over a month to go before the first day of classes, 13,159 students have registered for 133,154 Fall 2025 semester student credit hours (SCH). Year-over-year this represents a nearly 5 percent growth percent in headcount (612 additional students) and a nearly 7 percent increase in SCH registration (8,146 SCH).

Compared to last year at this time, UAA headcount is up almost 6 percent (383 additional students), and SCH is 8 percent higher (5,454 SCH). See page 2 for additional UAA detail by academic unit.

UAF headcount increased over 6 percent (302 students), with students registering in 7 percent more (3,369) SCH year-over-year. See page 3 for additional UAF detail by academic unit.

At UAS, student headcount is nearly 7 percent (75 students) lower and student credit hour registration dropped about 8 percent (676 SCH) compared to this time last year. See page 4 for additional UAS detail by academic unit.


Course Registration 5 Weeks to Start of Fall Semester Instruction Fall 2024 and Fall 2025 (July 22 2024 and July 21 2025)




