

Preliminary Applications, Admissions, Enrollment and Revenue Activity
14 Weeks Before Start of Instruction
Fall 2023 Semester

The following is a summary of fall semester 2023 enrollment activity as of May 22nd, 2023. Fall semester registration opened one week earlier in 2023 than in 2022. Information reported here is normalized relative to the first day of instruction for a given term.

Trends are still preliminary, currently there are 14 weeks before instruction begins. Activity so far indicates about 19,970 students will enroll in approximately 166,000 student credit hours by the close of fall semester 2023. This suggests a decrease of about 1 percent in headcount year over year and little change to student credit hours compared to fall semester 2022 (pages 4-5).

Systemwide application, admission, and enrollment activity is up over 6 percent (502), 5 percent (204), and 4 percent (260) respectively. Undergraduate program applications increased 6 percent from last year with underlying increases in first-time freshmen applications of 7 percent (346) and UA Scholar applications of almost 6 percent (41).

Graduate program applications are up nearly 8 percent (67) compared to last year and graduate admissions are up almost 2 percent (5). The number of admitted undergraduate students is 5 percent (235) higher year-over-year, with first-time freshman admissions up nearly 8 percent (264). The number of UA Scholars who applied and have been admitted has seen little change from 2022.

About 20 percent (715) of admitted first-time freshman have elected to enroll in fall 2023 courses, an increase of about 31 percent (170) from this time last year. About 26 percent (141) of UA Scholars also chose to enroll in fall courses, which is an increase of close to 25 percent (28) from last year. As of Monday, 7,501 students had registered for 76,553 fall semester student credit hours, an increase of about 4 percent and 6 percent respectively compared to fall 2022.

Systemwide, net tuition and fee revenue is up almost 8 percent (\$2.2M) from last year. Undergraduate and graduate tuition is up from last year, with increases of just over 8 percent (\$1.4M) and 6 percent (\$125.3K). See page 2 for additional information and details.


