Spring 2024 Course Registration, Revenue and Applications Sixth Week of Spring 2024 Instruction February 20, 2024

The following is a summary of spring semester enrollment activity as of Tuesday, February 20, 2024. Students will continue to enroll in short and late start classes through the end of the term.

About 21,480 students are anticipated to enroll by the close of spring 2024, a projected increase of about 5.5 percent (1,117 students) over spring 2023. Likewise, student credit hour registration is anticipated to increase by about 6 percent (9,504 SCH) over last year, reaching 163,700 SCH by the end of term. Graphs displaying historical and current course registration patterns for headcount and SCH are provided on pages 5 and 6, respectively.

By the sixth week of spring 2024 instruction, 19,136 students were registered for 157,930 credit hours, system wide. This represents an increase of about 6 percent in headcount (1,103 students) and student credit hour registration (9,762 SCH), year-over-year. UAA student headcount increased 10.3 percent (1,044 additional students) and student credit hours are up 9.1 percent (7,483 SCH) compared to last year. UAF student headcount is 2.3 percent (153 students) higher and student credit hour registration is 4.6 percent (2,452 SCH) higher than this time last year. UAS headcount is 2.2 percent (42 students) higher and student credit hour registration 1.4 percent (173 SCH) lower than this time last year. Net tuition and fee revenue for spring 2024 totals \$56.8M currently, an increase of 6.6 percent (\$3.5M) over last year at this time. Undergraduate tuition revenue increased 6.8 percent (\$2.3M) and graduate tuition revenue increased 10.7 percent (\$0.5M) compared to last year. UAA revenue is up 7.3 percent (\$2.0M), UAF revenue is up about 7.0 percent (\$1.5M), and UAS revenue is consistent with 2023. 
