Spring 2024 Course Registration, Revenue and Applications First Day of Spring 2024 Instruction January 16, 2024

The following is a brief, initial summary of spring semester enrollment activity as of Tuesday, January 16, 2024. Figures have been normalized relative to the first day of instruction for spring term. Spring 2024 instruction started January 16 and students will be able to add or drop classes through Friday, January 26. Students enrolling in short and late start classes will continue to drive additional enrollment until the end of the term.

At this point, roughly 80 percent of all students who will likely enroll by the end of spring 2024 have already registered in 94 percent of spring 2024 student credit hours (SCH). Nearly 4,240 additional students are anticipated to enroll by the close of spring 2024, for a total of about 21,100 students, an increase of about 2.4 percent (490 students) over spring 2023. Student credit hour registration is also expected to increase by about 5 percent (8,230 SCH) over last year, reaching almost 162,000 SCH by the end of term. Refer to pages 6 and 7 for graphs displaying historical and current course registration patterns for headcount and SCH, respectively.

As of January 16, 2024, 16,616 students have registered for 152,116 spring semester credit hours, system wide. This represents an increase of just over 4 percent in headcount (652 additional students) and a near 6 percent (8,539 SCH) increase in student credit hour registration from the levels observed at the start of spring 2023. UAA student headcount grew about 7 percent (618 additional students) and student credit hours are up about 8 percent (5,924 SCH) compared to last year. UAF student headcount is close to 3 percent (161 students) higher and student credit hour registration is nearly 6 percent (2,992 SCH) higher than spring 2023. UAS headcount is 1 percent (18 students) higher and student credit hour registration is close to 3 percent lower than this time last year.

On average across the system, each student has registered for more than 9 course credits, potentially generating \$3,420 in tuition and fee revenue, a 2 percent increase in both the average course credits and generated tuition and fees over spring 2023. Net tuition and fee revenue for spring 2024 totals \$56.8M, up about \$3.4M from spring 2023, currently. Both graduate and undergraduate tuition revenue increased just over 7 percent (\$2.4M in undergraduate revenue and \$0.4M in graduate revenue)

compared to last year. UAA revenue is up about 7 percent (\$1.9M), UAF revenue is also up about 7 percent (\$1.5M), and UAS revenue is consistent with that observed this time last year. See page 4 for additional to-date trends by revenue category and university.

Across the UA system 5,158 applications have been initiated by prospective students for admission in spring 2024, up about 21 percent (878 applications) from spring 2023. Increases in the number of applications initiated by prospective first-time freshman were observed at each university, compared to last year: applications started or completed for UAA grew by just over 19 percent (211 applications), for UAF by about 66 percent (187 applications), and for UAS by close to 30 percent (33 applications). Applications initiated by an individual may be pending information or may be completed and ready for admission consideration. Figures reported here and on page 5 will be larger than some university reports with figures for completed applications only. Information about admissions and matriculation of accepted program majors is being validated for addition to this report in the future.


