Spring 2024 Course Registration, Revenue and Applications Third Week of Spring 2024 Instruction January 30, 2024

The following is a summary of spring semester enrollment activity as of Tuesday, January 30, 2024. Figures have been normalized relative to the first day of instruction for spring term. The last day to drop semester-long courses for a full refund has passed at each university; students will continue to enroll in short and late start classes through the end of the term.

To-date, spring 2024 course registration activity surpasses that observed for spring 2022 and spring 2023. Estimates indicate 84 percent of all students who will enroll by the end of spring 2024 have already registered in 95 percent of student credit hours (SCH).

About 21,250 students are anticipated to enroll by the close of spring 2024, a projected increase of about 4.6 percent (890 students) over spring 2023. Likewise, student credit hour registration is anticipated to increase by about 6 percent (8,400 SCH) over last year, reaching 162,600 SCH by the end of term. Graphs displaying historical and current course registration patterns for headcount and SCH are provided on pages 6 and 7, respectively.

By the third week of spring 2024 instruction, 17,915 students were registered for 154,583 credit hours, system wide. This represents an increase of 6 percent in headcount (935 students) and student credit hour registration (8,654 SCH), year-over-year. UAA student headcount increased 10.2 percent (936 additional students) and student credit hours are up 8.7 percent (6,992 SCH) compared to last year. UAF student headcount is 1.4 percent (93 students) higher and student credit hour registration is 4 percent (2,127 SCH) higher than this time last year. UAS headcount is 2.1 percent (39 students) higher and student credit hour registration 3.7 percent (465 SCH) lower than this time last year. Net tuition and fee revenue for spring 2024 totals \$56.7M currently, an increase of 6.1 percent (\$3.2M) over last year at this time. Undergraduate tuition revenue increased 6.5 percent (\$2.2M) and graduate tuition revenue increased 9.6 percent (\$0.5M) compared to last year. UAA revenue is up 7 percent (\$1.9M), UAF revenue is up about 6.5 percent (\$1.4M), and UAS revenue is down by about 2 percent (\$83.0

thousand) compared to this time last year. See page 4 for additional to-date trends by revenue category and university.

Across the UA system 5,205 applications have been initiated by prospective students for admission in spring 2024, up about 20 percent (849) from spring 2023. Increases in the number of applications initiated by prospective first-time freshman were observed at each university, compared to last year: applications started or completed for UAA grew by just over 16 percent (446), for UAF by about 24 percent (324), and for UAS by close to 22 percent (79). Applications initiated by an individual may be pending information or may be completed and ready for admission consideration. 
