


Student Trends - Spring 2024

University of Alaska is the state's system for providing higher education, with three distinct, accredited universities. UA is fundamental to Alaska's economy, delivering relevant programs that qualify graduates to take current and future jobs in the state. Now, ongoing efforts to steady and grow enrollment are having a clear impact.

Final spring semester data becomes available in early June each year, allowing information about dual enrollment courses delivered in high schools to be added to the university's management information system through the end of May.

Five-year trend projections student of headcount, to the right, and student credit hours, below, demonstrate enrollment has increased significantly between Spring 2023 and Spring 2024 semester. Current patterns indicate final Spring 2024 headcount will be more than 5 percent higher (~1,000 students) than in Spring 2023. This continues an upward trend that significant overall started last spring, а improvement relative to the average 8 percent annual declines (~1,800 avg/year) observed between Spring 2020 and Spring 2022.





Similarly, Spring 2024 student credit hour delivery is anticipated to increase by an estimated 6.0 percent (9,300 SCH) over Spring 2023 levels, following a small decrease of less than 1 percent in student credit hours between Spring 2022 and Spring 2023. In the three years prior, between Spring 2020 and Spring 2022, annual declines averaged 10 percent (~18,700 avg/year) for student credit hours attempted by students.

Total net tuition and fee revenue is 6.2 percent (\$3.3M) higher than this time last year (page 2). Increases in undergraduate tuition revenue (\$2.1M, +6.2%) and graduate tuition revenue (\$0.5M, +10.7%) accounted for most of the growth from last year.

More than 60 percent of main campus academic units and community campuses grew in both student headcount and credit hour registration compared to last year. Detailed information about student headcount, credit hour production by unit, campus and university are available on page 3.
