


## Student Trends - Fall 2023


University of Alaska is the state's system for providing higher education, with three distinct, accredited universities. UA empowers Alaska, delivering relevant programs that qualify graduates to work in 90 percent of job occupations in the state. In fall semester 2023, UAA, UAF and UAS enrolled the equivalent of almost 4 percent of Alaska's adult population. Enrollment is growing again, reversing past enrollment declines tied to the pandemic and state funding cuts. A brief overview of enrollment activity at the close of the fall 2023 semester is below, followed by select data summary tables.

Student headcount grew 2.6 percent in total (more than 500 students) between fall 2022 and fall 2023, a significant overall improvement relative to the average 6.7 percent annual declines (~1,600 avg/year) occurring between fall 2019 and fall 2022 (p. 2). The growth in student headcount occurred across the board for each university.

The total number of student credit hours delivered to students also increased in fall 2023, up 3.6 percent (almost 6,000 SCH) year-over-year from fall 2022 (p. 3).



The number of entering, first-time freshman from Alaska grew 15 percent (247) in the last year. A larger proportion of the entering class is being attracted from other U.S. states, increasing from 7 to 11 percent of incoming students each fall in the last 5 years. As new incoming students are retained over time and graduate, total enrollment will continue to increase.



Community campus credit hour enrollment was especially impacted by the pandemic and has now returned to fall 2020 levels, growing 8 percent total in the last year. Anchorage, Troth Yeddha' and Juneau campuses typically deliver more than 70 percent of total UA credit hours, and in aggregate grew 2 percent between fall 2022 and fall 2023.



Adding figures across reporting levels will result in duplication because it is common for students to be concurrently enrolled at more than one academic organization (AO) and/or more than one university in the same semester. Figures count students who audit for-credit courses and exclude students taking only one or more non-credit courses.
