## Summary: Enrollment

In Fall 2025, 20,526 students enrolled for credit in the University of Alaska system representing a 4.6 percent (897) increase from the Fall 2024 headcount of 19,629 students, and a 1.1 percent (219) decrease from the Fall 2021 headcount of 20,745 (Table 1). Part-time students made up 56.1 percent of the student body in Fall 2025, with full-time students accounting for the remaining 43.9 percent (Table 3). Of those enrolled for credit, 73.4 percent (15,072 students) are enrolled in degree seeking programs compared with 69.3 percent (14,381 students) in Fall 2021 (Table 16).

Graduate students accounted for 9.6 percent (1,977 students) of all students attending UA in Fall 2025, and 62.5 percent (1,236 students) of graduate students are enrolled part-time (Table 4). Master's student enrollment increased 7.1 percent from 1,414 in Fall 2012 to 1,515 in Fall 2025, and a 4.8 percent (61 students) increase compared to Fall 2024. Doctorate students have increased by 30.2 percent from 298 students in Fall 2021 to 388 students in Fall 2025, and this is a 16.5 percent (55 students) increase compared to Fall 2024 (Table 16).

Lower division and preparatory courses accounted for 71.3 percent (132,186 student credit hours) of coursework delivered by the UA system in Fall 2025. Upper division courses accounted for 20.6 percent (38,138) of student credit hours, while professional and graduate courses accounted for 8.2 percent (15,230) of all student credit hours (Table 39).

The number of first-time freshmen attending UA in Fall 2025 was 2,491, a 4.6 percent increase from the Fall 2024 number of 2,381 and a 36.8 percent increase over the Fall 2020 number of 1,821 (Table 18). At UA Anchorage, 1,493 first-time freshmen enrolled in Fall 2025, a 9.5 percent increase from Fall 2024. UA Fairbanks enrolled 874 first-time freshmen, a 3.3 percent increase from the previous year. First-time freshmen attending UA Southeast decreased 26.4 percent from Fall 2024 to 117 students in Fall 2025 (Table 18).

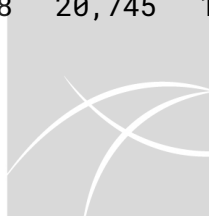
The top three Alaska Census origin areas for first-time freshmen were Anchorage (892), Fairbanks North Star Borough (327) and Matanuska-Susitna (280). The top three out-of-state origin locations for first-time freshmen were Washington (46), California (28), and Texas (22). Overall, students originating from in-state accounted for 87 percent (2,161) of Fall 2025 first-time freshmen, with students originating from out of state or another country accounting for 11.3 percent (283) and 1.8 percent (47), respectively (Table 19).

In Fall 2025, 57.1 percent of students were under the age of 25, and 6.6 percent are students over 50 years old (Table 7).

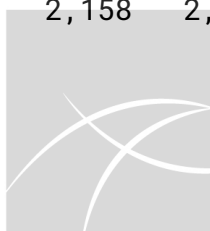

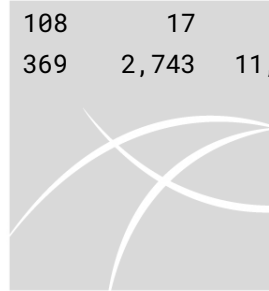

In Fall 2025, 5.6 percent of student credit hours (SCH) were taken by students enrolled in three or fewer credits, accounting for 21.1 percent of the total headcount (Table 21). Students enrolled in 12 SCH or more accounted for 63.5 percent of UA's total SCH and represented 41.1 percent of the total student headcount. Students enrolled in 15 SCH or more accounted for 26.6 percent of UA's total SCH and 14.9 percent of UA's total student headcount.

Note: Due to rounding, university totals may not add exactly. A student may take credit hours at multiple AOs within a university or multiple universities within the system. Consequently, the credit hours attempted per student may shift to higher categories when moving from the AO level to the university level to the system level. The sum of credit hours per student for AOs or universities in a given category will not equal the credit hours per student at the same level for the university or system.

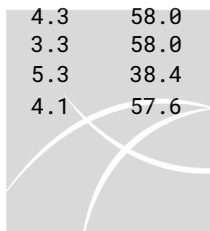
