 - Jennifer Ward Faculty Alliance retreat in Anchorage and they will set their 3 year priorities. Of note, Ian Hartman was awarded Historian of the Year for a book he co-authored; History of Black People in Alaska. They will also discuss faculty retention and administration evaluations at the retreat.
