1. Status check on the issue when class roster and SSASECT were not showing the same number of students enrolled  
Russ is working on the LRGP fix – will email shortly, test will be needed.
2. Schedule when SI-SFRBWLP should be turned on/off for each term in PROD and LRGP.

SFRBWLP, waitlist process is now scheduled to run:

For 201501, every 15 minutes from now until May 1, 2015 for 201502, every 15 minutes from now until you tell us to stop it.

For 201503, every 15 minutes from now until you tell us to stop it.

Jane: same time as SOATERM set up let her know to turn it on.  
Add to SOATERM notes.

3. Holds screen (attached, Mary)

Action for different type of holds. AR holds do not prevent online payment.  
All approved to make a change.

4. Adding Spring 2014 back to UAOnline (UAS – attached)  
Registrars discussed this: UAA was concerned regarding turning 20101 back on during 201501 grading to avoid faculty confusion. It's OK to turn it on for a period of time after 201501 grading is done. Agreed to move it to the next agenda and decide on the date on 5/14/15.  
UAS does not expect this to be needed every term in the future.

5. Upgrade from college scheduler. Please see the message attached.  
Jane: the upgrade is the ability to gather statistics from the scheduler. However, it's not yet available in the interface. Jane will find out exactly how we would be able to get access to the stats if the upgraded package is released in prod.

Jane: No way to get there yet.

Just raising awareness: refresh shifted to another date from May 9. No final date yet. Know it's not ready for PROD – Patty should know that LRGP will have a new copy. Jane will send in the date as soon as she knows. Lindsey will check with Patty. Matt's work in LRGP will be wiped out if the changes are in data base. Programs will not be written over.
