Executive Summary


Under the oversight of the Chief Strategy, Planning, and Budget Officer, the University of Alaska Land Management Office (UALM) manages the University of Alaska's real property assets. This report covers the financial performance of the Land Management Office for fiscal year 2025 (July 1, 2024 – June 30, 2025) as required by Board Policy P05.11.041 D.



The ~150,000 acres of real property assets managed by the Land Management Office cover a vast geographic area from Kotzebue to Ketchikan. Management and monetization of these assets includes leasing, easements, land sales, building sales, permitting, forest management and timber sales, material sales, trespass management, and title defense. Additionally, our office oversees the acquisition of land through the university land grants, purchase, and donation.


Over the past 5 years, the average annual revenue was \$6.88 million. In FY25, the university received \$5.78 million in gross receipts. \$1.66 million was distributed to the universities and the UA Foundation in FY25.

Expenses for FY25 amounted to \$5.43 million. UALM's expenditures include operational expenses for property management, internal debt service, and salaries and benefits. The fiscal year reflected lower net revenue due to increased focus on projects that will generate increased returns in the following fiscal years.



Revenue Overview

Gross revenue for FY25 was \$5.78 million and expenditures totaled \$5.43 million. Revenue came from \$1.20 million in land sales, \$3.92 million in leases, \$287,792 in permits and fees, \$67,000 from easements and \$314,199 from natural resources. Expenditures include \$1.82 million in salaries and benefits and \$3.61 million in operating costs.



Revenue is distributed based on how a property was acquired or managed. Universities can request proceeds from the sale or lease of most real property assets with the exception of certain original trust lands. In FY25, \$1.24 million went to the campuses.


Revenue Overview (cont.)

Proceeds that go to the LGTF and IPF support UA Scholars, a portion of the Land Management budget, and many other important university initiatives. In FY25, the LGTF and IPF balances at fiscal year-end were \$193 million and \$61.5 million respectively.

Funding Supports UA Scholars


Each year the UA Scholars programs offers a \$15,000 scholarship to the top 10% of graduates from qualified Alaska schools.

The [UA Scholars Program](#) is one of our proudest funding achievements. This program is a cornerstone of the University's efforts to keep our youth in state and to educate Alaska's brightest graduating high school seniors. Students are designated by their own community high school based on academic standing at the end of their junior year.

Asset Class Overview

Commercial & Residential Leasing

During FY25, UALM's real estate leasing activities included approximately 67 commercial, residential, and land leases, with the university as landlord and/or tenant. Out of these, 50 leases, on designated land, were directly managed by UALM on behalf of the universities.

\$3.92M *FY 25 Total Lease Revenue*

UALM oversaw the leasing of 313,232 square feet of commercial space across 7 buildings, accruing \$3.92 million in gross receipts, a 1.3 percent decrease from FY24. Demand for commercial office space remained flat over the past fiscal year.

The Bragaw Office Complex and the University Lake buildings continue to generate the most revenue of the commercial properties that the University holds; however, these properties also have higher expenses. The revenues from these properties are allocated for the University's internal debt service, totaling \$1.4 million annually.

For residential leasing, UALM managed apartment leases in Dillingham for UAF, and also a waterfront cabin in Valdez. UALM also administered 25 land leases covering approximately 240 acres. These land leases include cellular towers, the UAS Tech Center lease to the City and Borough of Juneau, and the KAKM land lease for an antenna located at Goose Bay.

Easements

UALM executed 2 easements in FY25. The cumulative easement fees totaled \$67,000 with the following distributions of benefits: \$60,500 to the Land Grant Trust Fund, and \$6,500 to UAA.

Sales

UALM closed 20 sales in FY25, with 83.07 total acres sold. Total sales revenue was \$1.20 million. The Tebenkof View Subdivision outside Whittier generated strong sales in FY25. This subdivision had not previously been offered for sale and generated 6 lot sales totaling \$459,760 for the Land Grant Trust Fund. Other notable transactions included two Sterling area parcels for \$170,240 and \$130,500, respectively, on behalf of the UA Foundation to benefit the Brockel Family Scholarship and John C. Brockel Memorial Scholarship Endowment at Kenai Peninsula College.

Permitting

UALM currently manages 122 active permits and agreements, of which the university is the permittee or permitter. Sixty-one (61) of these permits and agreements are for educational purposes and managed by UALM. The permits can be further broken down into five cell tower or antenna sites, three coffee stands, 27 general land use permits, six parking permits and agreements, and 20 water rights appropriations. Overall, in FY25, permits and agreements generated \$287,792 in rental income for UALM, a small increase over last year. Year-to-year, improved tracking and management practices provide UALM with a better understanding of the positive impact permits and agreements can have on annual revenue.

UALM is working to standardize and streamline the permitting process, reducing processing times from application to execution. In addition, UALM is preparing a hunting permit program that will authorize hunting on most non-residential UA lands excluding, educational properties, active land sale listings, subdivisions, and areas with existing agreements that would conflict with hunting. UALM is also working to create a commercial big game hunting permitting program.

Research Permits

In addition to our permit issuance program from UA lands, UALM secures permits on lands held by external agencies and private parties for university researchers at no additional cost to the university. UALM currently manages over 280 active research permits. UALM facilitated 68 new research permits in FY25. These permits support diverse research areas spanning environmental, geological, and space science and contribute to UAF's effort to achieve R1 research status.

Natural Resources

Natural resource development on university land includes timber sales, firewood permits, material sales, coal leasing, and oil and gas leasing. Overall gross revenue from natural resource development was \$314,199 largely due to continued royalties from oil and gas and material sales.

Forestry

In forestry, one active timber sale in Vallenar Bay on Gravina Island completed operation in FY25. Close-out was complete with select roads preserved for potential future development of the property. We increased firewood permit costs in FY25 and areas available for harvest to support different communities throughout the state. We are still reviewing and assessing timber assets.



Oil & Gas

In oil and gas exploration, there were three active leases for a total of \$147,139.

Mining & Materials


Material sales in various locations yielded differing royalties and lease rents for FY25. Gross revenue from material sales was \$109,211. and gross revenue from mineral leasing was \$57,819. We continue to explore new opportunities for the expansion and development of new material sites statewide.

2022 Land Grant Initiative

Thanks to the incredible work of Alaska's Congressional Delegation, and in particular Senator Lisa Murkowski, a federal bill was drafted that provides a mechanism for the U.S. to convey lands from Alaska's remaining statehood entitlement to the university.

The spending package passed by Congress at the end of 2022 included the University of Alaska Fiscal Foundation Act, which finally created a process for the University of Alaska to receive 360,000 acres of land from the federal government. The UALM has proposed selections totaling ~500,000 acres to the State of Alaska, Department of Natural Resources (DNR) to begin the State relinquishment process. The State of Alaska (DNR) has public noticed ~350,989 acres. A total of ~96,406 acres have been submitted to the Department of the Interior, U.S. Bureau of Land Management. As of June 30, 2025, no land has been conveyed by the U. S. Bureau of Land Management.

Priorities

The UALM acquisition priorities are guided by Board Policy. Our priority is to fulfill the university's land grant initiative, support campus objectives by considering and acquiring strategic properties, and to bring in real property for the UA Foundation.

Donations

UALM processed one gift of real property in FY25. There was a donation from Mary Croxton to benefit the Croxton Fellowship Annual Award through the University of Alaska Foundation.
